|                | Keith Craig outlined recent community concern regarding ongoing offensive odour detected near the roundabout on Kooragang Island, as well as near Stockton Bridge and in Stockton. Residents identified a definite canola-type odour and at other times a different offensive odour. KC acknowledged the progress of the installation of a biofilter system at Cargill Australia Ltd to reduce odour from oilseed processing. Meanwhile, odour complaints continue and the Stockton community requests a response from the EPA.   |  |  |  |  |

|                | Mark Hartwell (EPA) confirmed Cargill's large capital investment in a biofilter system, designed to reduce odour by 98%, to be installed by August 2012. MH noted that Cargill's Environment Protection Licence includes a Pollution Reduction Program to mitigate odour. Within 30 days of commissioning the works, Cargill must engage a suitably qualified person to test the effectiveness of the biofilter. Cargill must report to EPA, by 31 December 2012, providing an overview of the works and results of the post commissioning performance assessment. The licence is available on the EPA  |  |  |  |  |

|                | Graham Woods (Industry) confirmed that Incitec's Queensland plant operates $N_20$ reduction technology. Typically, reduction technology operates on new plants rather than existing plants. However, the carbon tax now provides a financial incentive to investigate retrofitting of abatement technology on older plants, on a case-by-case basis.  |  |  |  |  |  |  |
