VARIATION OF NOTICE OF CLEAN-UP ACTION

BACKGROUND

- A. The Environment Protection Authority (EPA) issued Notice of Clean-up Action No. to CRUSH AND HAUL PTY LIMITED on .
- B. On 12 January 2015, the EPA received correspondence from Crush and Haul Pty Limited requesting review of the notice to reflect Crush and Haul Pty Limited 'active working area' within the Premises.
- C. The EPA has taken this request into consideration and is varying Notice 1536719.




Figure 1. Property and Premises location (Source: https://maps.six.nsw.gov.au/)

- D. "The Property" is defined as 1953-2109 Elizabeth Drive, Badgerys NSW 2171 (Lot 101 DP848215) (Figure 1).
- E. "The Premises" is defined as shown in Figure 1 and 2.
- F. The Crush and Haul Pty Limited "active working area" is defined as shown in Figure 3.
- G. The EPA requires Crush and Haul Pty Limited to take clean-up action.

VARIATION OF NOTICE OF CLEAN-UP ACTION

 By this notice the EPA varies Notice of Clean-up Action No. ("the previous notice") in the following manner:

All clean up action detailed in the previous notice is replaced by:

- 2. The Environment Protection Authority (EPA) directs CRUSH AND HAUL PTY LIMITED to take the following clean-up action:
 - i. Immediately cease causing the receipt of any waste at the Premises.



- ii. Immediately cease processing waste stored at the Premises.
- iii. By no later than **5pm Thursday 21 January 2016** cause sediment and erosion controls at the Premises to be reinstated.
- iv. By no later than **5pm Thursday 21 January 2016** cause dust management controls to be installed at the Premises.
- v. By no later than **5pm Thursday 21 January 2016** cause leachate management controls to be installed at the Premises.
- vi. By no later than **5pm Friday 5 February 2016** cause the classification of all material stored in the active working area.
- vii. By no later than 4pm Monday 8 February 2016 provide classification reports to the EPA.
- viii. By no later than **5pm Friday 26 February 2016**, cause waste stored within the active working area, including all glass fines, unprocessed concrete and brick, recovered fines, soil and road base to be:
 - a. removed from the Property; and
 - b. transported to and disposed of at a facility that can lawfully receive that waste type.
- ix. By no later than **4pm Wednesday 2 March 2016**, cause all original records* for clean-up, transport, and disposal of this waste to be provided to the EPA.
- x. By no later than **5pm Friday 11 March 2016**, cause waste stored within the active working area including all crushed aggregate and processed and unprocessed quarry material to be:
 - a. removed from the Property; and
 - b. transported to and disposed of at a facility that can lawfully receive that waste type.
- xi. By no later than **4pm Wednesday 16 March 2016**, cause all original records* for clean-up, transport, and disposal of this waste to be provided to the EPA.
- xii. By no later than **5pm Monday 11 April 2016**, cause all remaining waste stored within the active working area:
 - a. removed from the Property; and
 - b. transported to and disposed of at a facility that can lawfully receive that waste type.
- xiii. By no later than **4pm Friday 15 April 2016**, cause all original records* for clean-up, transport, and disposal of this waste to be provided to the EPA.
- xiv. Ensure compliance with section 120 of the Act.
- xv. Ensure compliance with section 126 of the Act. Removal of waste must be carried out in a manner that minimises the generation of dust and prevents the emission of dust from the Premises.
- xvi. No material, including sediment or oil, is to be tracked from the Property.
- xvii. Trucks leaving the Premises that are carrying loads must be covered at all times except during loading.

*Note: "Records" required by this Clean-Up Notice must include (but are not limited to): registration of all vehicle(s) used to transport the waste; date that the waste was transported and disposed; business name/company name and ABN of the waste disposal facility (or facilities) to which the waste was



transported; location of each facility where the waste was transported; and receipts / weighbridge dockets / invoices for waste transport and disposal.
