

## Littering from vehicle report – under 18

Only use this form if you are under the age of 18.

You must submit your report within 14 days of the offence.

All fields are mandatory, except where indicated. Your parent or guardian must be contactable on the phone number provided.

The EPA will not be able to process your report if:

- there is not enough information provided to validate your report
- your parent or guardian is not contactable
- your parent or guardian does not provide consent for you to attend court as a witness if the offender elects to have the matter dealt with in court.
